Purpose	Use this application to apply for Open Registration of a Coonhound. Once submitted, this application becomes the property of the American Kennel Club.						
Eligibility Requirements for Open Registration	 Eligibility Criteria: The dog is of a breed eligible for individual registration in the American Kennel Club Stud Book, at the direction of the AKC[®] Board of Directors (a list of eligible breeds is available on our Web site: www.akc.org/reg/open_registration.cfm) or the dog is registered with one of the domestic registries listed in the Special Registry Services pamphlet available on our Web site: www.akc.org/rules/special_registry_services.cfm. 						
	The dog was born in the United States or one of its possessions or territories.						
	• The dog is individually registered with a registry organization whose pedigrees are acceptable to the AKC for Open Registration.						
	• The owner of the dog is a resident of the United States or one of its possessions or territories.						
	A dog is not eligible for individual Open Registration if its litter has been registered with the American Kennel Club. Normal procedures for registering individual dogs must be followed instead.						
Required Attachments	The following items must accompany the completed, signed application: Certificate of Registration. Attach an 8.5" x 11" photocopy of the original registration certificate issued by the applicable registry identifying the applicant as the recorded owner of the dog. Do not send the original certificate.						
	 Pedigree. Attach an 8.5" x 11" photocopy of the original pedigree issued by the U.S. registry containing at least three generations of ancestry (with registration numbers for each dog), establishing that each dog in the three generations was of the same breed and registered with a registry whose pedigrees are acceptable to the AKC. Do not send the original pedigree. If any of the dogs appearing in the ancestry are imported, the pedigree must include the Stud Book initials 						
	and the foreign registration number issued for the dog by the registry organization in the dog's country of birth. A dog will be ineligible for AKC registration if the pedigree issued by the U.S. registry discloses that one or more dogs were recorded with the registry on the basis of an affidavit.
